SPOTSYLVANIA COUNTY
CONTRACT AGREEMENT
FOR GOODS AND SERVICES
CONTRACT #14-05-25-02

THIS MODIFICATION #3 TO SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR GOODS AND SERVICES is made as of _____, 2017 by and between BOARD OF SUPERVISORS OF SPOTSYLVANIA COUNTY, a political subdivision of the Commonwealth of Virginia, hereinafter referred to as the "COUNTY", and, ANDERSON OIL COMPANY, INC., a Virginia Corporation, hereinafter referred to as "CONTRACTOR".

WITNESSETH:

WHEREAS, the COUNTY, the SCHOOL BOARD OF SPOTSYLVANIA (hereinafter referred to as "SCHOOLS"), and the CONTRACTOR entered into an Agreement, as attached hereto, titled "SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR GOODS AND SERVICES" (hereinafter the "AGREEMENT") dated April 23, 2014, to obtain the purchase of #2 heating oil for the Spotsylvania County Government; and

WHEREAS the COUNTY and the CONTRACTOR subsequently renewed the AGREEMENT for a one (1) year term by entering into the "Modification #1 to Spotsylvania County Contract Agreement for Goods and Services, Contract #14-05-25-02" dated and executed on April 17, 2015 which term commenced on April 23, 2015, and Modification #2 to Spotsylvania County Contract Agreement for Goods and Services, Contract #14-05-25-02" dated and executed on April 13, 2016 which term commenced on April 23, 2016, and

WHEREAS, the COUNTY¹ requires a continuation of these services for an additional one (1) year contract term, as is permitted under Article 2, subdivision 2.2., of the initial contract dated April 23, 2014, and

¹ The SCHOOLS may or may not choose to renew, but if so, then under a separate document solely between the SCHOOLS AND CONTRACTOR.

WHEREAS, the COUNTY and the CONTRACTOR have determined that it is to their mutual benefit to modify the AGREEMENT further by entering into this "Modification #3 to "Spotsylvania County Contract Agreement For Goods and Services."

NOW, THEREFORE, the COUNTY and the CONTRACTOR in consideration of the mutual promises herein contained, and intending to be legally bound, do hereby modify terms and conditions of the AGREEMENT as follows:

A. ARTICLE 2, THE WORK AND AGREEMENT TERM LIMITS 2.2 is hereby deleted in its entirety and replaced as follows:

2.2. The Agreement shall be effective April 23, 2017 and shall be for one year ending April 22, 2018 and may be renewable thereafter for one (1) additional one (1) year term at the sole option of Spotsylvania County.

Except as hereby modified, the AGREEMENT remains unchanged and in full force and effect.

IN WITNESS WHEREOF, the parties hereto have caused Modification #3 to Spotsylvania County Contract Agreement for Goods and Services to be duly executed by their duly authorized officials as of the date first written above and effective April 23, 2017.
