## MODIFICATION #4 TO SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR GOODS AND SERVICES IFB #13-09-31

THIS MODIFICATION #4 TO SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR GOODS AND SERVICES is made as of \_\_\_\_\_\_, 2017 by and between BOARD OF SUPERVISORS OF SPOTSYLVANIA COUNTY, a political subdivision of the Commonwealth of Virginia, ("COUNTY"); and GALLS, LLC, a Kentucky Limited Liability Company, ("CONTRACTOR").

## WITNESSETH:

WHEREAS, the COUNTY and the CONTRACTOR entered into an Agreement with Best Uniforms, Inc., titled "SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR GOODS AND SERVICES" ("AGREEMENT") dated June 27, 2013, for new uniforms for the Sheriff's Office in Spotsylvania County; and

WHEREAS the AGREEMENT was subsequently renewed for a one (1) year contract term by the "Modification #1 to Spotsylvania County Contract Agreement For Goods and Services, IFB #13-09-31", dated and executed on June 25, 2014, which term commenced on June 27, 2014; and

WHEREAS the CONTRACTOR has purchased Best Uniforms, Inc.; and

WHEREAS the AGREEMENT was subsequently modified and renewed for a one (1) year contract term by the "Renewal #2 to Spotsylvania County Contract Agreement For Goods and Services, IFB #13-09-31", dated and executed on June 4, 2015, which term commenced on June 27, 2015; and "Modification #3 to Spotsylvania County Contract Agreement for Goods and Services, IFB #13-09-31", dated and executed on June 8, 2016, which term commended on June 27, 2016 and

WHEREAS, the COUNTY requires a continuation of these goods and services for an additional one (1) year contract term, as is permitted under Article 2, subdivision 2.2 of the initial contract dated June 27, 2013; and

WHEREAS, the COUNTY and the CONTRACTOR have determined that it is to their mutual benefit to renew the AGREEMENT as modified further by entering into this "Modification #4 to Spotsylvania County Contract Agreement for Goods and Services, IFB #13-09-31".

NOW, THEREFORE, the COUNTY and the CONTRACTOR in consideration of the mutual promises herein contained, and intending to be legally bound, do hereby modify terms and conditions of the AGREEMENT as modified by Modification #3 as follows:

- A. SECTION 2.2. OF ARTICLE 2, THE WORK AND AGREEMENT TERM LIMITS, is hereby deleted and replaced as follows:
- 2.2. This Agreement shall have a term limit of one (1) year effective from June 27, 2017 through June 26, 2018.
- B. The following portion of SECTION 4.2 OF ARTICLE 4, CONTRACT PRICE AND TERMS OF PAYMENT, of the AGEEMENT and Renewal #2 is hereby deleted and replaced as follows:
