WHEREAS, upon finding the property is owned by the Estate of Melvina Scott Holliday, who died intestate in April, 1970, extensive research was conducted to determine and locate the heirs of the Estate of Melvina Holliday. The heirs were determined to be, in order of degree of relation and highest share percentage: Michael B. Holliday (grandson), Barrajean A. Holliday (grandson), Donna L. Dangerfield (great-granddaughter), Joseph K. Holliday, Jr., (great-grandson), Queen Ann Rogers (grandson's wife and heir), Delores H. Johnson (great-granddaughter), Roberta Norfleet (great-granddaughter), Regina Holliday (great-granddaughter), and Kayla Holliday (great-granddaughter).

**WHEREAS,** Building Safety sent certified letters to the known addresses of the property owner(s) on or about July 14, 2017. Two letters were returned unclaimed, and no response was received from the other heirs.

WHEREAS, Spotsylvania County Code Section 5-4 requires property owner(s) to remove, repair or secure dangerous structures when directed by the County and provides for removal or repair by the County when property owner(s) fail to do so within the specified time frame

**WHEREAS,** Spotsylvania County Code Section 5-4 provides that the cost of such removal shall constitute a lien against such property ranking on parity with liens for unpaid local taxes and enforceable in the same manner.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF SPOTSYLVANIA: THAT the subject structure might endanger the public health or safety of other residents of the County; therefore, the heirs of the Estate of Melvina Scott Holliday, which owns the property of 16540 Days Bridge Road, are hereby directed to remove, repair or secure said unsafe structure located on this parcel within thirty (30) days of this Resolution.

**BE IT FURTHER RESOVLVED**: That notice shall be published in the *Free Lance Star* once per week for the next two successive weeks, which shall direct all heirs of the Estate of Melvina Scott Holliday, as heirs of the property owner of 16540 Days Bridge Road to remove, repair or secure said unsafe structure within thirty (30) days from the date of this Resolution. No action shall be taken by the County to remove, repair, or secure said structure for at least thirty (30) days following said newspaper publication pursuant to Spotsylvania County Code Section 5-4 and Virginia Code Section 15.2-906.

**BE IT FURTHER RESOVLVED**: That should the heirs of Estate of Melvina Scott Holliday, as heirs of the property owner of 16540 Days Bridge Road fail to remove, repair or secure the said unsafe structure within the timeframe above, staff is directed to take any and all action necessary to do the same including the expenditure of funds to remove or repair said structure, with costs and expenses chargeable to and paid by the property owner(s), at this time being the Estate of Melvina Scott Holliday, and to place a lien against said property for collection of same.

# Zoning Notices

Staff presented an overview of the various ways the public is informed about zoning actions such as special use permit and rezoning applications. These include notices required by the Code of Virginia, Spotsylvania County Code, and by Board adopted policy. Draft Community Meeting Recommended Guidelines that increases notification radii for various types of applications was presented for Board consideration and adoption.

Based on feedback received from the Board and the public, an updated recommended notification radius was proposed in the Community Meeting Guidelines that sets a minimum 3,000 foot radius for projects that may have wider spread sound, vibration, or similar impacts.

Mr. McLaughlin made a motion to adopt the community meeting recommended guidelines to include the minimum 3,000 foot radius.

Mr. Ross made a friendly amendment to bring back the sign options and prices, the ability to use spotsy alert for notifications and cell tower distance.

The motion, to include the friendly amendment, passed unanimously.

#### iDX Surplus Property

48.07469 acres of substantially unimproved property behind the idX Corporation plant on Tidewater Trail (referred to as the "Back Forty") is to be transferred to the EDA to be marketed for industrial development. Paragraph 23 of the Agreement sets forth the covenant and agreement of the EDA that "it shall not develop the Back Forty property or otherwise transfer any interest in the Back Forty Property, including, but not limited to, any lease or license, without the express consent of the Board of Supervisors of Spotsylvania County." The Agreement also contains an Option provision (Paragraph 13) whereby the Board of Supervisors may elect to take title to the Back Forty property directly. The public hearing required by statute for the Board's consideration of its option to take title to the property was held at the Board's meeting on August 8. The Board may now, by motion and vote, choose to exercise the option to take title to the Back Forty itself, or may, by taking no action, forego exercising its Option and allow the Back Forty property to pass to the EDA. In consideration of the flexibility afforded to them under state law in matters concerning business development, staff notes that marketing of the Back Forty may be undertaken most efficiently and effectively by the EDA. Paragraph 12 of the Agreement makes any disposition of the property subject to approval by the Board of Supervisors, so the Board will have the final word on the disposition and future use of the property.

#### **RESOLUTION NO. 2017-114**

**WHEREAS,** once acquired by the EDA, the development or transfer of the Property must still be approved by the County pursuant to the Purchase and Sale Agreement;

**NOW, THEREFORE, BE IT RESOLVED** that the Board does hereby authorize and direct Mark B. Taylor, County Administrator, to advise the EDA and 11032 Tidewater Trail, LLC that the Board at this time has declined to exercise its option to purchase the Property and that the parties should prepare for the transfer of the Property to the EDA pursuant to the Purchase and Sale Agreement and to take all steps he deems necessary and reasonable to effectuate the transfer.

### Government and Military Affairs Committee

The Chamber of Commerce recently parted ways with the Fredericksburg Regional Military Affairs Committee (MAC) and started a Chamber committee, the Government and Military Affairs Committee (GMAC). Spotsylvania has been a member of the MAC for many years, and appointed Supervisor Cebula as its representative to the MAC and Deputy County Administrator Cole as an alternate.
