THIS MODIFICATION #3 TO SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR PROFESSIONAL SERVICES, Contract #14-12-46-02 is made as of \_\_\_\_\_, 2017 by and between BOARD OF SUPERVISORS OF SPOTSYLVANIA COUNTY, a political subdivision of the Commonwealth of Virginia, ("COUNTY"); and MOSELEY ARCHITECTS, P.C., a Virginia Corporation, ("CONSULTANT"), in good standing and duly licensed to do business in the Commonwealth of Virginia.

WITNESSETH:

WHEREAS, the COUNTY and the CONSULTANT entered into an Agreement titled "SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR PROFESSIONAL SERVICES, Contract #14-12-46-02" ("AGREEMENT") dated November 14, 2014, to provide professional architectural and engineering services for multiple projects for Spotsylvania County; and

WHEREAS, the AGREEMENT was subsequently renewed by "Modification #1 to Spotsylvania County Contract Agreement for Professional Services, Contract #14-12-46-02" dated and executed on November 13, 2015, and "Modification #2 to Spotsylvania County Contract Agreement for Professional Services, Contract #14-12-46-02" dated and executed on November 11, 2016, and

WHEREAS, the COUNTY requires a continuation of these goods and services for an additional one (1) year contract term, as is permitted under Article 2, subdivision 2.3., of the initial contract dated November 14, 2014, and

WHEREAS, the COUNTY and the CONSULTANT have determined that it is to their mutual benefit to modify the AGREEMENT further by entering into this "Modification #3 to Spotsylvania County Contract Agreement For Professional Services, Contract #14-12-46-02".

NOW, THEREFORE, the COUNTY and the CONSULTANT in consideration of the mutual promises herein contained, and intending to be legally bound, do hereby modify terms and conditions of the AGREEMENT as follows:

A. SECTION 2.3, OF ARTICLE 2, THE WORK AND AGREEMENT TERM LIMITS, is hereby deleted in its entirety and replaced as follows:

2.3. This Agreement shall have a term limit of one (1) year effective from November 14, 2017 through November 13, 2018 and may be renewable for one (1) additional one (1) year term at the option of Spotsylvania County.

Except as hereby modified, the AGREEMENT remains unchanged and in full force and effect.

IN WITNESS WHEREOF, the parties hereto have caused Modification #3 to Spotsylvania County Contract Agreement For Professional Services, Contract #14-12-46-02 to be duly executed by their duly authorized officials as of the date first written above, and effective November 14, 2017.
