THIS MODIFICATION #3 TO SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR GOODS AND SERVICES, Contract #15-02-08-02 is made as of ________ 2018 by and between BOARD OF SUPERVISORS OF SPOTSYLVANIA COUNTY, a political subdivision of the Commonwealth of Virginia, hereinafter referred to as the "COUNTY"; and PLEXUS INSTALLATIONS, INC., a Maryland Corporation, authorized to do business in Virginia, hereinafter referred to as "CONTRACTOR".

WITNESSETH:

WHEREAS, the COUNTY and the CONTRACTOR entered into an Agreement titled "SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR GOODS AND SERVICES Contract #15-02-08-02" (hereinafter the "AGREEMENT") dated January 14, 2015, to provide materials and services for fiber optic cable outside plant installation and/or fiber optic and cooper cable inside plant installation in Spotsylvania County; and

WHEREAS, the AGREEMENT was subsequently renewed by "Modification #1 to Spotsylvania County Contract Agreement for Goods and Services, Contract #15-02-08-02" dated and executed on January 5, 2016; and renewed by "Modification #2 to Spotsylvania County Contract Agreement for Goods and Services, Contract #15-02-08-02" dated and executed on January 3, 2017; and

WHEREAS, the COUNTY requires a continuation of these goods and services for an additional one (1) year contract term, as is permitted under Article 2, subdivision 2.2., of the initial contract dated January 14, 2015, and

WHEREAS, the COUNTY and the CONTRACTOR have determined that it is to their mutual benefit to modify the AGREEMENT further by entering into this Modification #3 to "Spotsylvania County Contract Agreement For Goods and Services, Contract #15-02-08-02".

NOW, THEREFORE, the COUNTY and the CONTRACTOR in consideration of the mutual promises herein contained, and intending to be legally bound, do hereby modify terms and conditions of the AGREEMENT as follows:

A. SECTION 2.2, OF ARTICLE 2, THE WORK AND AGREEMENT TERMILIMITS, is hereby deleted in its entirety and replaced as follows:

2.3. This Agreement, upon expiration of the initial contract term, shall have a term limit of one (1) year effective from January 14, 2018 through January 13, 2019 and may be renewable for one (1) additional one (1) year term at the sole option of Spotsylvania County.

Except as hereby modified, the AGREEMENT remains unchanged and in full force and effect.
