THIS MODIFICATION #4 TO COUNTY OF SPOTSYLVANIA CONTRACT AGREEMENT FOR GOODS, Contract #14-01-10-01 is made as of _____, 2018 by and between BOARD OF SUPERVISORS OF SPOTSYLVANIA COUNTY, a political subdivision of the Commonwealth of Virginia, ("COUNTY"); and UNIVAR USA INC., a Washington Corporation, in good standing and duly licensed to do business in the Commonwealth of Virginia, ("CONTRACTOR").

WITNESSETH:

WHEREAS, the COUNTY and the CONTRACTOR entered into an Agreement titled "COUNTY OF SPOTSYLVANIA CONTRACT AGREEMENT FOR GOODS, Contract #14-01-10-01" ("AGREEMENT") dated January 29, 2014, to obtain water treatment chemicals for Spotsylvania County; and

WHEREAS the AGREEMENT was subsequently renewed for a one (1) year term by the "Modification #1 to County of Spotsylvania Contract Agreement for Goods, Contract #14-01-10-01" dated and executed on January 28, 2015 which term commenced on January 29, 2015, a second "Modification #2 to County of Spotsylvania Contract Agreement for Goods, Contract #14-01-10-01" dated and executed on January 28, 2016 which term commenced on January 29, 2016, and a third "Modification #3 to County of Spotsylvania Contract Agreement for Goods, Contract #14-01-10-01" dated and executed on January 29, 2017 which term commenced on January 29, 2017, and

WHEREAS, the COUNTY requires a continuation of these goods for an additional one (1) year contract term, as is permitted under Article 2, subdivision 2.2., of the initial contract dated January 29, 2014, and

WHEREAS, the COUNTY and the CONTRACTOR have determined that it is to their mutual benefit to modify the AGREEMENT further by entering into this "Modification #4 to County of Spotsylvania Contract Agreement For Goods, Contract #14-01-10-01".

NOW, THEREFORE, the COUNTY and the CONTRACTOR in consideration of the mutual promises herein contained, and intending to be legally bound, do hereby modify terms and conditions of the AGREEMENT as follows:

A. ARTICLE 2, subdivision 2.2., THE WORK AND AGREEMENT TERM LIMITS, is hereby deleted in its entirety and replaced as follows:

2.2. This Agreement shall have a term limit of one (1) year effective from January 29, 2018 through January 28, 2019.

Except as hereby modified, the AGREEMENT remains unchanged and in full force and effect.

IN WITNESS WHEREOF, the parties hereto have caused Modification #4 to County of Spotsylvania Contract Agreement for Goods, Contract #14-01-10-01 to be duly executed by their duly authorized officials as of the date first written above, and effective January 29, 2018.
