February 2018 VDOT Transportation Briefing**

Battlefield District, Christopher J. Yakabowski

- **Construction** – No active projects to report on

- **Preliminary Engineering** –
 - **I-95 Exit 126, Route 1 SB onto Southpoint Parkway (UPC 110914)**
 - Current schedule has construction beginning in 2021
 - Survey has been completed and preliminary design work is underway

Berkeley District, Kevin W. Marshall

- **Construction** –
 - **Route 606 (Mudd Tavern Road) over I-95 Bridge Replacement & Roadway Improvements East of I-95(UPC 100829/105463)**
 - Project awarded to Shirley Contracting. Project Kick-Off meeting held on December 13, 2016
 - Public Hearing took place on April 27, 2017 at River View Elementary School from 5 PM to 7 PM
 - Pardon Our Dust meeting was held on September 18, 2017 at River View Elementary school.
 - Construction started October 2017 and project is scheduled to be completed September 2019

 - **Route 17/ Route 609 (Thornton Rolling Road) Intersection Improvements (UPC 105893)**
 - Intersection improvements include additional turn lanes on Route 17 and Thornton Rolling Road along with the installation of a signal
 - Project was awarded to J.L. Kent & Sons for approximately \$1.6 million
 - Contractor was issued NTP on January 10th
 - E&S measures are complete and the contractor has begun clearing and grubbing

 - **Station 8 Safety Enhancements**
 - Updated pavement markings were installed in May 2017
 - Pre-construction meeting at Station 8, October 10, 2017
 - All pre-emption equipment has been installed
 - Flashing beacons will be installed this spring

- **Preliminary Engineering**
 - **Route 606 (Mudd Tavern Road) Roadway Improvements West of I-95 (UPC 105464)**
 - Citizen Information Meeting held May 20, 2014 for roadway improvements west side of interchange, conceptual designs presented
 - Access management study completed for Route 606 between I95 and Route 1
 - Project approved for funding under SMART Scale
 - Met with Planning Commission on July 20th and sent County an update regarding potential solutions to the access management concerns
 - Project maps were displayed at the Route 606 East Pardon Our Dust Meeting on September 18, 2017. The displays included the connector road between Dan Bell and South Roxbury Mill
 - Public Hearing was held on November 14, 2017 at Thornburg Middle School
 - Project to be advertised for construction December 2019

 - **Route 658 (Mount Olive Road) Bridge Replacement (UPC 81501)**
 - Preliminary Engineering is underway
 - Project team met with both Hanover and Spotsylvania County to discuss design alternatives, and Counties would like to see a bridge two lane bridge to accommodate the local industry traffic
 - Project was advertised on December 12, 2017 and in the process of being awarded to the selected bidder.
 - Public hearing was held October 6, 2016 at The Partlow Ruritan Club from 5 PM to 7 PM

Chancellor District, Timothy J. McLaughlin

- **Construction** – No active projects to report on
- **Preliminary Engineering** –
 - **Route 620 (Harrison Road) Reconstruction (UPC 107141)**
 - Preliminary Engineering is underway
 - Project scope alternatives discussed at September Transportation Committee Meeting
 - County submitted revenue sharing application to fund ultimate design configuration
 - Current advertisement is Fall 2021
 - **Spotswood Furnace Road Rural Rustic (UPC 110859)**
 - E&S plan and environmental work has been completed
 - Hard surfacing to be completed this spring/early summer

Courtland District, David Ross

- **Construction** –
 - **I-95 Safety Improvements at Route 3 (UPC 107715)**
 - Design build project with Branch Civil and WRA
 - Pardon our dust meeting was held June 8, 2017
 - Major traffic shift occurred on December 7, 2017
 - Minor traffic shift in the next couple of weeks (weather permitting) on ramp from WB Rte. 3 to NB I-95 to allow for grading. Majority of focus currently is the slip ramp from SB I-95 to Central Park.
 - Project estimated to be complete in January 2019
- **Preliminary Engineering** – No active projects to report on

Lee Hill District, Gary F. Skinner

- **Construction** – No active projects to report on
- **Preliminary Engineering** –
 - **Route 17 (Mills Drive) Bridge replacement and Roadway widening (UPC 107140)**
 - Project will replace structurally deficient Bridge over 95 and widen Route 17 to four lanes to Hospital Blvd
 - Preliminary Engineering is underway
 - Project funded with Smart Scale and Revenue Sharing funds
 - Public Hearing was held on August 23, 2017 at Lee Hill Elementary School from 5 PM to 7 PM.
 - Current advertisement is Fall 2021
 - **Commonwealth Drive Commuter Parking Lot**
 - Project to build a new a new Park & Ride lot near Route 1 and Commonwealth Drive
 - Lot will have about 700 parking spaces
 - Preliminary engineering is on-going
 - Public hearing was held on January 11, 2018 at Cedar Forest Elementary School
 - Project scheduled to begin construction in 2020

Livingston District, Greg Benton - Chair

- **Construction** – No active projects to report on
- **Preliminary Engineering** –
 - **Woolfolk Road Rural Rustic (UPC 110859)**
 - E&S plan and environmental work has been completed
 - Hard surfacing to be completed this spring/summer
 - **Route 731 (Mount Holly Drive) Rural Rustic (UPC 110722)**
 - Preliminary Design and environmental work is underway

Salem District, Paul D. Trampe - Vice Chair

- **Construction** – No active project to report on
- **Preliminary Engineering** – No active projects to report on

VDOT Administered Studies:

- **Strategically Targeted and Affordable Roadway Solutions (STARS) – I95 Northbound at US1 (Exit 126)**
 - Project kick-off meeting was held on September 25, 2017
 - Study to look at affordable ways to address the NB Route 1 to NB 95 traffic concerns
 - Study to be completed for potential SMART SCALE project submittal

Maintenance Items:

- Benchmark Road over Massaponax Creek
 - Emergency pipe replacement to replace a triple line 13' x 8' corrugated metal arch pipes with a triple 12' x 10' box culvert. The road was closed on February 12th and will remain closed until the replacement can be completed.
 - An emergency contract is currently being developed and our goal is to begin work within a month.
 - We plan to incentivize the contract to expedite the work.
 - Currently we anticipate the construction taking approximately 12 weeks once the contractor has mobilized and prepared the site.
