SPOTSYLVANIA COUNTY CONTRACT AGREEMENT
FOR PROFESSIONAL SERVICES

THIS MODIFICATION #4 TO SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR PROFESSIONAL SERVICES is made as of _____, 2018 by and between BOARD OF SUPERVISORS OF SPOTSYLVANIA COUNTY, a political subdivision of the Commonwealth of Virginia, ("COUNTY"); and CHERRY BEKAERT LLP, a Limited Liability Partnership, ("CONTRACTOR").

WITNESSETH:

WHEREAS, the COUNTY and the CONTRACTOR entered into an Agreement titled "SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR PROFESSIONAL SERVICES Contract #14-06-26", ("AGREEMENT") dated April 9, 2014, to obtain auditing and consulting services for Spotsylvania County; and

WHEREAS, the AGREEMENT was subsequently renewed and/or modified by "Modification #1 to Spotsylvania County Contract Agreement for Professional Services, Contract #14-06-26" dated and executed on March 24, 2015, which term commenced on April 9, 2015, "Modification #2 to Spotsylvania County Contract Agreement for Professional Services, Contract #14-06-26" dated and executed on March 23, 2016, which term commenced on April 9, 2016, and "Modification #3 to Spotsylvania County Contract Agreement for Professional Services, Contract #14-06-26" dated and executed on April 3, 2017, which term commenced on April 9, 2017, and

WHEREAS, the COUNTY requires a continuation of these services for an additional one (1) year contract term, as is permitted under Article 2, subdivision 2.3., of the initial contract dated April 9, 2014, and

WHEREAS, the COUNTY and the CONTRACTOR have determined that it is to their mutual benefit to modify the AGREEMENT further by entering into this "Modification #4 to Spotsylvania County Contract Agreement for Professional Services Contract #14-06-26".

NOW, THEREFORE, the COUNTY and the CONTRACTOR in consideration of the mutual promises herein contained, and intending to be legally bound, do hereby modify terms and conditions of the AGREEMENT as follows:

A. ARTICLE 2, THE WORK AND AGREEMENT TERM LIMITS, subdivision 2.3., is hereby deleted in its entirety and replaced as follows:

2.3. This Agreement shall have a term limit of one (1) year effective from April 9, 2018 through April 8, 2019.

B. ARTICLE 4, CONTRACT PRICE AND TERMS OF PAYMENT, subdivision 4.2.1., is hereby deleted in its entirety and replaced as follows:

4.2.1. The COUNTY agrees to pay a lump sum fee not to exceed One Hundred Thirty Thousand Nine Hundred Sixty-Six Dollars and Twenty Cents (\$130,966.20) for auditing and consulting services for the fiscal year ending 2018.

Except as hereby modified, the AGREEMENT remains unchanged and in full force and effect.
