



Chapter 1 – Introduction and Vision

 Vision statement: Spotsylvania families will enjoy a community that remembers and respects its place in our nation's history and builds on the principles of our founding fathers to provide freedom and prosperity through limited government, respect for property rights, low taxes and pro-business policies for the 21st Century.

Chapter 1 – Introduction and Vision

- Review, update, and amend Guiding Principles and Strategies to guide the Plan development
 - A. Spotsylvania County is a "business friendly" community and local job creation is a priority.
 - B. Spotsylvania County is fiscally sustainable.
 - C. Spotsylvania County is a family friendly community.
 - D. Agriculture and silviculture are valued components of Spotsylvania County's economy.
 - E. Spotsylvania County values its environmental resources.

Chapter 2 – Land Use

- Review current Primary Development Boundary and determine if any changes are needed to the boundary or policies
 - Staff suggests addressing areas in PBD that are not serviceable by public water and sewer in the near term (phased approach)
- Review the land use categories and determine if they are appropriate and whether any new categories are needed
 - Staff suggests refining Employment Center and Institutional Land Use, establishing density maximums and reviewing expectations for Mixed Use areas, and re-evaluating Lake Anna Mixed Use area
- Update Future Land Use Map
- Review and update land use policies

Chapter 3 – Transportation & Thoroughfare Plan

- Review and update transportation policies and strategies
- Review and update the Thoroughfare Plan
 - Develop a prioritized/scaled list of projects to guide future funding decisions
 - Include any new road connections?

- Review and update each facility focusing on levels of service, service areas, and facility standards
