RESOLUTION NO. 2018-48

Approve with Conditions Special Use Permit SUP18-0004 Zoan Baptist Church

WHEREAS, Zoan Baptist Church requests special use permit approval to allow a private school on Residential 1 (R-1) zoned property. The property is located at 5888 Plank Road which is on the south side of Plank Road (Route 3) approximately 1,500 feet west of the Harrison Road (Route 620) and Plank Road (Route 3) intersection. The property is located within the Primary

Development Boundary. The property is identified for Institutional development on the Future Land Use Map of the Comprehensive Plan. Tax parcel 22-A-38. Chancellor Voting District; and

WHEREAS, staff has reviewed the subject application and recommends approval with conditions as stated in the staff report and the executive summary; and

WHEREAS, the Spotsylvania County Planning Commission held a public hearing on April 4, 2018, duly advertised in a local newspaper for a period of two weeks, and interested citizens were given an opportunity to be heard; and

WHEREAS, the Spotsylvania County Planning Commission recommended approval of the project with a vote of 5-0; and

WHEREAS, the Spotsylvania County Board of Supervisors held a public hearing on April 24, 2018, duly advertised in a local newspaper for a period of two weeks, and interested citizens were given an opportunity to be heard; and

WHEREAS, the Spotsylvania County Board of Supervisors considered the Special Use Permit request in accordance with Sec. 23-4.5.7, Standards of Review, and finds that the application with the recommended conditions satisfies the following standards:

- 1. That the proposed use is in accord with the comprehensive plan and other official plans adopted by the county;
- 2. That the proposed use or development of the land will be in harmony with the scale, bulk, coverage, density, and character of the area or neighborhood in which it is located;
- 3. That the proposed use will not hinder or discourage the appropriate development and use of adjacent land and buildings or impair the value thereof;
- 4. That the proposed use will not adversely affect the health or safety of persons residing or working in the neighborhood of the proposed use;
- 5. That the proposed use will not be detrimental to the public welfare or injurious to property or improvements within the neighborhood;
- 6. That the proposed use is appropriately located with respect to transportation facilities, water supply, wastewater treatment, fire and police protection, waste disposal, and similar facilities;
- 7. That the proposed use will not cause undue traffic congestion or create a traffic hazard; and
- 8. That the proposed use will have no unduly adverse impact on environmental or natural resources.

WHEREAS, general welfare and good zoning practice are served by approval of the Special Use Permit application;

NOW, THEREFORE, BE IT RESOLVED that the Spotsylvania County Board of Supervisors does hereby approve SUP18-0004 Zoan Baptist Church with the conditions listed below:

- 1. The maximum allowable number of students shall be one hundred and twenty (120). Any increase in the number of students beyond 120 shall require an amendment to the special use permit.
- 2. All Building and Fire Code requirements must be adhered to as the student enrollment increases within the maximum allowable number of students.

Resolution Increasing Rabies Vaccination Fee at County Rabies Clinics from \$6.00 to \$10.00 per Vaccine for Each Pet Immunized for the Fall 2018 Clinic

Owners of dogs and cats vaccinated at county rabies immunization clinics pay a set fee of \$6.00 for each dog and/or cat vaccinated. The county pays all additional clinic costs, which have risen to the point that it is necessary to increase the vaccination fee so the owners of the animals vaccinated, rather than the county, absorb these costs. Analyses of the fees and costs from the past two clinics and fees charged by adjoining jurisdictions for their rabies clinics, show \$10.00 per vaccine to be appropriate to cover clinic costs.

RESOLUTION NO. 2018-49

A Resolution Increasing Rabies Vaccination Fee at County Rabies Clinics from \$6.00 to \$10.00 per Vaccine for Each Pet Immunized Beginning with the Fall 2018 Clinic

WHEREAS, animals who have been infected by rabies continue to pose a serious and serious and fatal threat to Spotsylvania County residents and their pets;

WHEREAS, rabies is fatal to humans if untreated;

WHEREAS, the best way to prevent the spread of rabies to humans and their pets is by keeping dogs and cats over the age of four months old properly vaccinated;

WHEREAS, Virginia Code Section 3.2-6521 requires the Board of Supervisors to approve all rabies immunization clinics within the County;

WHEREAS, Virginia Code Section 15.2-1200 grants the Board the power to adopt necessary regulations to prevent the spread of contagious diseases among animals;

WHEREAS, the County conducts two such rabies immunization clinics each year, one in the spring, and one in the fall;

WHEREAS, the Board of Supervisors finds that, for approximately ten years, the owners of dogs and cats vaccinated at County rabies immunization clinics have paid a set fee of \$6.00 for each dog and/or cat vaccinated. The County pays all additional clinic costs, which have risen to the point that it is necessary to increase the vaccination fee;

WHEREAS, the Board of Supervisors finds that, at the Spring, 2017 County rabies immunization clinic, the immunization fee was \$6.00 per vaccine. 571 animals were vaccinated, with their owners paying a total of \$3,426.00. The County's total clinic costs, including veterinarian other personnel costs, syringes, tags and advertising, totaled \$5,760.00;

WHEREAS, the Board of Supervisors finds that, at the Fall, 2017 County rabies immunization clinic, the immunization fee was \$6.00 per vaccine. 685 animals were vaccinated, with their owners paying a total of \$4,110.00. The County's total clinic costs, including veterinarian other personnel costs, syringes, tags and advertising, totaled \$6,592.00;

WHEREAS, the Board of Supervisors finds that increasing the fee from \$6.00 to \$10.00 per vaccine for each dog and cat vaccinated at County rabies immunization clinics, beginning with the Fall 2018 clinic, will satisfy most, if not all, of the County's rabies immunization clinic costs, allow provision of additional services, and place costs on those who use the clinic rather than on the County;

WHEREAS, the Board of Supervisors finds that two adjoining counties charge fees of \$10.00 per vaccine at their rabies immunization clinics, and the fees of all of the adjoining jurisdictions exceed the \$6.00 per vaccine presently charged by County.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF SPOTSYLVANIA: THAT the County's rabies vaccination fee shall be increased from \$6.00 to \$10.00 per vaccine for each dog and cat vaccinated at the County's rabies immunization clinics beginning with the Fall 2018 clinic.
