SPOTSYLVANIA COUNTY  
CONTRACT AGREEMENT  
FOR GOODS AND SERVICES  
CONTRACT #14-10-39

THIS MODIFICATION #4 TO SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR GOODS AND SERVICES is made as of May 18, 2018 by and between BOARD OF SUPERVISORS OF SPOTSYLVANIA COUNTY, a political subdivision of the Commonwealth of Virginia, ("COUNTY"), and, REVERE GAS, INC., a Virginia Corporation, hereinafter referred to as "CONTRACTOR".

WITNESSETH:

WHEREAS, the COUNTY and the CONTRACTOR entered into an Agreement titled "SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR GOODS AND SERVICES" Contract #14-10-39 ("AGREEMENT") dated June 25, 2014, to obtain delivered propane gas for Spotsylvania County<sup>1</sup>; and

WHEREAS the AGREEMENT was subsequently renewed for a one (1) year term by "Renewal #1 to Spotsylvania County Contract Agreement for Goods and Services, Contract #14-10-39" dated and executed on June 10, 2015 which term commenced on June 26, 2015; and "Modification #2 to Spotsylvania County Contract Agreement for Goods and Services, Contract #14-10-39" dated and executed on June 15, 2016 which term commenced on June 26, 2016, and "Modification #3 to Spotsylvania County Contract Agreement for Goods and Services, Contract #14-10-39" dated and executed on June 16, 2017 which term commenced on June 26, 2017, and

WHEREAS, the COUNTY requires a continuation of these services for an additional one (1) year contract term, as is permitted under Article 2, subdivision 2.2 of the initial contract dated June 25, 2014; and

WHEREAS, the COUNTY and the CONTRACTOR have determined that it is to their mutual benefit to modify the AGREEMENT further by entering into this "Modification #4 to Spotsylvania County Contract Agreement for Goods and Services Contract #14-10-39".

NOW, THEREFORE, the COUNTY and the CONTRACTOR in consideration of the mutual promises herein contained, and intending to be legally bound, do hereby modify terms and conditions of the AGREEMENT as modified by "Renewal #1 to Spotsylvania County Contract Agreement for Goods and Services, Contract #14-10-39", "Modification #2 to Spotsylvania County Agreement for Goods and Services, Contract #14-10-39" and "Modification #3 to Spotsylvania County Agreement for Goods and Services, Contract #14-10-39" as follows:

A. ARTICLE 2, THE WORK AND AGREEMENT TERM LIMITS 2.2 is hereby deleted in its entirety and replaced as follows:

2.2. The Agreement shall be effective June 26, 2018 from June 25, 2019.

B. ARTICLE 4, CONTRACT PRICE AND TERMS OF PAYMENT 4.2 is hereby deleted in its entirety and replaced as follows:

4.2. The COUNTY agrees to pay differential price per gallon of propane for the duration of the contract as follows:

a. Propane Gas \$0.2033

Except as hereby modified, the AGREEMENT as renewed and modified by "Renewal #1 to Spotsylvania County Contract Agreement for Goods and Services, Contract #14-10-39", "Modification #2 to Spotsylvania County Agreement for Goods and Services, Contract #14-10-39" and "Modification #3 to Spotsylvania County Agreement for Goods and Services, Contract #14-10-39" remains unchanged and in full force and effect.
