THIS MODIFICATION #2 TO SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR PROFESSIONAL SERVICES is made as of ______, 2018 by and between BOARD OF SUPERVISORS OF SPOTSYLVANIA COUNTY, a political subdivision of the Commonwealth of Virginia, ("COUNTY"); and JOHNSON, MIRMIRAN & THOMPSON, INC., a Maryland corporation, in good standing and duly licensed to transact business in Virginia, ("CONTRACTOR").

WITNESSETH:

WHEREAS, the COUNTY and the CONTRACTOR entered into an Agreement titled "SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR PROFESSIONAL SERVICES Contract #15-03-12-01", ("AGREEMENT") dated June 15, 2016, to obtain professional engineering design services for various transportation improvement projects in Spotsylvania County; and

WHEREAS, the AGREEMENT was subsequently renewed and/or modified by "Modification #1 to Spotsylvania County Contract Agreement for Professional Services Contract #15-03-12-01" dated and executed on May 24, 2017; and

WHEREAS, the COUNTY requires a continuation of these services for an additional one (1) year contract term, as is permitted under Article 2, subdivision 2.2., of the AGREEMENT; and

WHEREAS, the COUNTY and the CONTRACTOR have determined that it is to their mutual benefit to modify the AGREEMENT further by entering into this "Modification #2 to Spotsylvania County Contract Agreement for Professional Services Contract #15-03-12-01".

NOW, THEREFORE, the COUNTY and the CONTRACTOR in consideration of the mutual promises herein contained, and intending to be legally bound, do hereby modify terms and

conditions of the AGREEMENT as modified by "Modification #1 to Spotsylvania County Contract Agreement for Professional Services Contract #15-03-12-01", as follows:

- A. ARTICLE 2, THE WORK AND AGREEMENT TERM LIMITS, subdivision 2.2., is hereby deleted in its entirety and replaced as follows:
- 2.3. This Agreement shall have a term limit of one (1) year effective from June 15, 2018 through June 14, 2019 and may be renewable for two (2) additional one (1) year terms at the option of Spotsylvania County.

Except as hereby modified, the AGREEMENT as modified by "Modification #1 to Spotsylvania County Contract Agreement for Professional Services Contract #15-03-12-01" remains unchanged and in full force and effect.
