Re: idX – Baltimore, Inc. and idX Impressions, LLC Merger and COF Performance Agreement

Dear Sirs:

idX – Baltimore, Inc. (“idX – Baltimore”), the County of Spotsylvania, Virginia (“Locality”), and the Economic Development Authority of the County of Spotsylvania, Virginia (“Authority”), entered into a Performance Agreement dated April 27, 2017 (the “Performance Agreement”), setting forth the terms and conditions of the Commonwealth’s Development Opportunity Fund Grant awarded to the Locality for the purpose of inducing idX – Baltimore to purchase, improve, equip, and operate its Facility in the Locality. Capitalized terms not otherwise defined in this letter agreement shall have such meaning as set forth in the Performance Agreement.

Section 9(a) of the Performance Agreement provides that idX Baltimore may not assign its rights and responsibilities under the Performance Agreement without the prior written consent of the Locality, the Authority and VEDP. VEDP has received documentation of the merger of idX – Baltimore with and into idX Impressions, LLC, under the name idX Impressions, LLC (“idX Impressions”). VEDP consents to the assignment by idX – Baltimore to idX Impressions of the rights and obligations of the Company under the Performance Agreement. By their signatures below, the Locality and the Authority likewise provide their consent.


