THIS MODIFICATION #2 TO SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR PROFESSIONAL SERVICES is made as of _____, 2018 by and between BOARD OF SUPERVISORS OF SPOTSYLVANIA COUNTY, a political subdivision of the Commonwealth of Virginia, hereinafter referred to as the "COUNTY"; and MARY WASHINGTON HEALTHCARE PHYSICIANS, a Virginia Corporation, in good standing and duly licensed to do business in the Commonwealth of Virginia, hereinafter referred to as "CONTRACTOR".

WITNESSETH:

WHEREAS, the COUNTY and the CONTRACTOR entered into an Agreement titled "SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR PROFESSIONAL SERVICES" (hereinafter the "AGREEMENT") dated September 28, 2016, to provide medical examination and evaluation services for various departments in Spotsylvania County (hereinafter the "AGREEMENT"), and

WHEREAS, the AGREEMENT was subsequently renewed by "Modification #1 to Spotsylvania County Contract Agreement for Professional Services, Contract #16-21-DB" ("MODIFIED AGREEMENT") dated and executed on September 13, 2017, and

WHEREAS, the COUNTY requires a continuation of these services for an additional one (1) year contract term, and

WHEREAS, the COUNTY and the CONTRACTOR have determined that it is to their mutual benefit to modify the AGREEMENT further by entering into this Modification #2 to "Spotsylvania County Contract Agreement for Professional Services, Contract #16-21-DB".

NOW, THEREFORE, the COUNTY and the CONTRACTOR in consideration of the mutual promises herein contained, and intending to be legally bound, do hereby modify terms and conditions of the AGREEMENT as follows:

A. SECTION 2.2, OF ARTICLE 2, THE WORK AND AGREEMENT TERM LIMITS, is hereby deleted in its entirety and replaced as follows:

2.2. This Agreement, upon the expiration of the initial contract term, shall have a term limit, as renewed, of one (1) year effective from September 28, 2018 through September 27, 2019 and may be renewable thereafter for two (2) additional one (1) year terms at the sole option of Spotsylvania County.

Except as hereby modified, the AGREEMENT remains unchanged and in full force and effect.
