## Overview

- Last updated June, 2013
- Site Plans submitted after the effective date must comply with new standards
  - Plans submitted prior to the effective date must comply with 2013 standards
- Regulatory and Construction Standards
- 2018 Update
  - Reliability = confidence
  - Resiliency = toughness
- Provided to industry for non-mandatory 30-day comment period
- Updates driven by Virginia Department of Health requirements
- Highlighted Changes:
  - Corrosion program, tracer wire requirements, after-hours inspections, material updates

## **Corrosion Program Improvements**

- Spotsylvania County is at high risk of corrosive soils
- Increased failures directly relating to corrosive soils
  - 3 unprotected bolt failures within last month;
    - Most recent 13 year old main near Dean Ridings Lane
    - Protection at time of construction: \$50/fitting
    - Repair value: \$20,000 to \$30,000

## **Corrosion Program Updates**

Soil Base Condition	Assumes good soils base	Assumes corrosive soils base
Testing Procedure	Industry 10 Point System	Industry Design Decision Model
Ductile Iron Pipe	Bare installation w/polywrap as needed (50-year design life)	Zinc coated pipe with enhanced V- Bio polywrap (100-year design life)
Bolt Installation	No coating required; failure observed in less than 6 months	Factory applied anti-corrosion coating or stainless steel (life of system)
Test Out Option	Allowed	Allowed
<b>Corrosion Program Item</b>	Material Cost Increase	Rate Payer ROI (50 years)
Zinc Coated Pipe	\$5 per linear foot	20,000% to 30,000%
Coated bolts	\$1 per bolt (<\$25/fitting)	100,000+%

# **After-Hours Inspections**

- Current Program
  - Inspections can be requested at anytime (regardless of weather)
  - 10 to 20 requests per year from 1 to 2 contractors
- Proposed Program
  - Rate: \$110 per hour with 2-hour minimum
    - Industry consultation agreed to revisit when Community Development fees updated
  - When: Major holidays, Before 7 a.m. and after 5 p.m., On weekends
  - Notice: 2 business days
- Not all activities require on-site inspection

# **Other Changes**

#### Materials

- Materials were updated to meet current industry specifications
- Brass Fittings Increase pressure rating requirements for areas greater than 100 PSI

#### **Tracer Wire Requirements**

- All Services
  - Customer protection
- All Gravity Sewer
  - Needed for service connection
- Improved materials
  - Sewer/water individual marking tape
  - Waterproof connectors
  - Improved signal

## **Future Considerations**

- Lifting of corrosive soil testing requirement for low/moderate risk areas
- HDPE service connections
- Auxiliary Water Systems (Program being finalized for commercial use)
- Early Utility Installation Permit
  - During early clearing and grading
  - Sanitary sewer installation only
- Bonding program improvements/consistency
- Alternative coating systems
