Subject: Economic Development/Fiscal Impact of sPower's SUPs - CCSC analysis

Dear Supervisors,

During your BOS meeting on Tuesday, I summarized CCSC's analysis of sPower's economic development and tax revenue claims and provided a hardcopy. Here is the link to that document:

Economic Development Summary to BOS - Fogarty 12Feb2019

We feel that it's critical to honestly evaluate the claimed economic benefits of this project. sPower and their attorney have made many claims in columns, at public meetings, in flyers mailed to residents and in newspaper advertisements. It's time those claims were thoroughly analyzed. It's our opinion that they don't hold much water. Highlights:

- During the last week Dave Hammond and I have talked with economic development officials at Currituck, Accomack and Southampton counties. All three said that they have seen no new economic development activity as a result of their utility solar plants. They also said that there was very little economic benefit during the construction phase of the project. We provided the names of those officials should you or staff want to reach out to them (Tab A).
- No data center is going to move to Spotsylvania County because of the sPower plant no evidence has been provided to support that claim.
- Estimates of construction jobs and economic impact have been inflated and aren't based on real world experience just an economic model. There will likely be <u>very little benefit to the County's economy from the construction phase</u>. (Tab A)
- Similarly the economic impact during the operations phase is minimal. A restaurant or grocery store would provide the same number of employees and income with a much smaller footprint and impact on the county (Tab B).
- We took the time to provide rebuttals to the FRA memo and the DMME letter and included those in the package. The FRA memo has serious flaws but nonetheless was included in the staff report to the Planning Commission. I reached out to FRA's President over a month ago and have received no substantive response. sPower has quoted from the DMME letter on several occasions so we think it's important to hear the other side of that. The Governor (through DMME) is trying to influence this vote! (Tabs C and D)
- Net tax revenue from the project will be vastly overshadowed by the loss of tax revenue from the sale of Fawn Lake lots to sPower, from decline in property values and from revenue loss due to loss of construction activity from unbuilt lots. We've provided an easier to read bar graph to depict those impacts (Tab E).
- sPower's promises of other contributions to the county (panels for schools, \$ for water improvements etc) are constantly changing and <u>unenforceable</u>. Cash proffers aren't allowed so it would all be based on the developer's promises.

• I included two articles that address sPower's credibility (Tabs F and G). Both are recent (2018) and should be cause for concern to anyone making a "handshake" deal with them. The one from Riverhead, NY involves sPower allegedly deceiving the local Planning Board.

This is a large document but I've broken it out into 7 tabs so that you can quickly locate our backup information. We would appreciate a close review of this information and are available to answer questions.

Our group has heard from a number of Supervisors that the economics of this huge proposal will be a critical factor in the decision making process - we believe that there should be no doubt that this project will be a net loser for the county financially.
