We hope this finds you well. The purpose of this letter is to notify you, pursuant to Spotsylvania County, Virginia ("County") guidelines, that our client, USGGB, LLC, is hosting a community meeting on **Thursday, February 28, 2019, at 7:00PM**, at Spotswood Elementary School, located at 400 Lorraine Avenue, Fredericksburg, VA 22408. The purpose of the meeting is to discuss our proposed rezoning application to develop a residential community with forty-nine (49) single family detached units and fifty-three (53) single family attached units on the above-referenced parcel. The property is located along Lafayette Boulevard, near the intersection with Village Drive. The property contains approximately 18.5 acres.

You are receiving this letter because you are an owner of record or the occupant of certain property located within 3,000 feet of the proposed project. Copies of this letter are also being sent to all known Homeowners Associations within 3,000 feet of the project, as well as members of the Board of Supervisors and Planning Commission.

We have also enclosed a map of the general vicinity of the development, showing the location of the subject property and its relation to the immediate area. The proposed generalized development plan will be available for your review at the meeting. Please join us to learn about this project as well as ask questions and provide comments.

In order to develop our project, we will be filing for rezoning approval from the County to change the existing land use from the current Residential (R-1) zoning to Planned Development Housing District 8 (PDH-8) zoning. 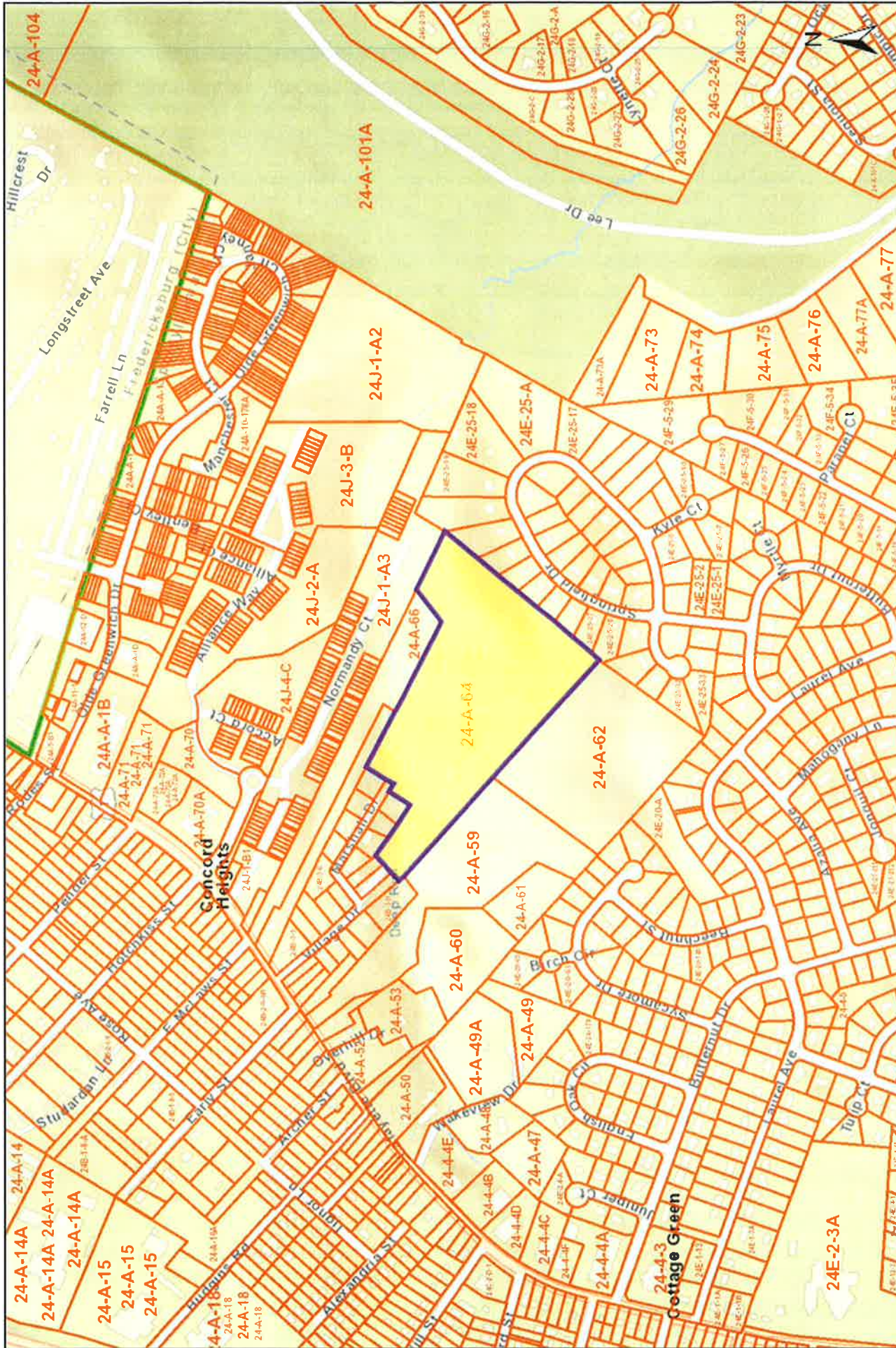
