NOTICE OF APPLICATION FOR REZONING

Tax Map Parcels 63-A-42, 63-A-43C and 63-A-44

As the owner/s of real property located within 3000 feet of identified property where a Rezoning is being applied for, you are being provided with this Notice of Rezoning request and a short description of the Applicant's proposed plan for the property.

Three parcels of adjoining land located in the Berkely Magisterial District (Spotsylvania Tax Map Parcels 63-A-42, 63-A-43C, and 63-A-44) are currently zoned by the County as both Commercial 3 (C-3) and Agricultural 2 (A-2). Approximately 10.2803 acres of a total of 61.6393 acres is zoned agricultural with the remaining 51.3590 acres already zoned Commercial 3 (C-3). The owners desire that all three parcels be fully zoned Commercial 3 (C-3) in order to provide for the highest and best future use of the property. No specific plan of development has been made at this time, but the future use will comply with the County's comprehensive plan.

The parcels are located to the south of Mudd Tavern Road (State Route 606) and are bound by Interstate 95 to the east and U.S. Route 1 to the west. See dark shaded area on the attached map for the location of the land being requested for rezoning.

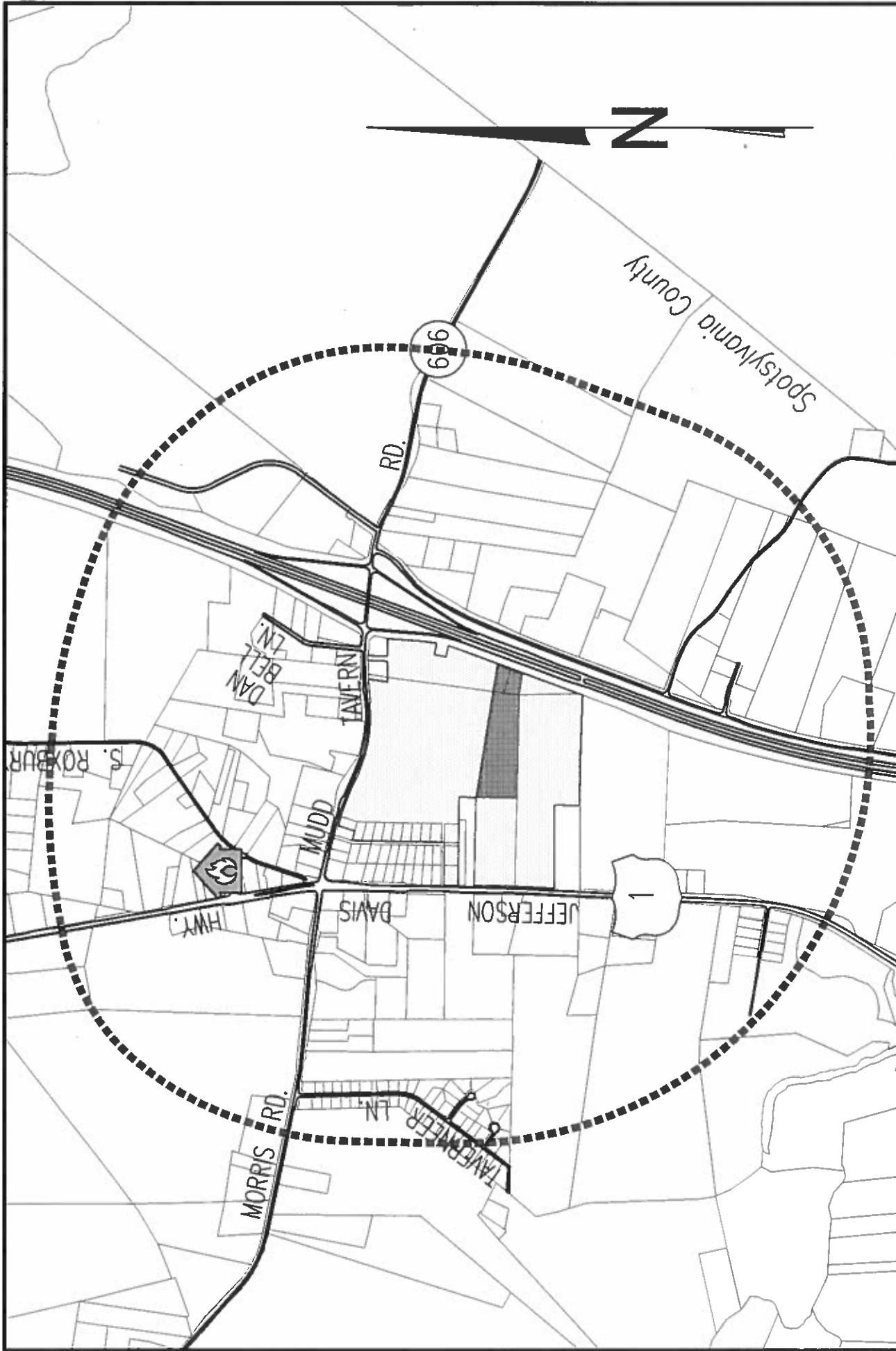
