RESOLUTION NO. 2018-24

Resolution on Regional Tourism Marketing Agreement

WHEREAS, there has been a regional program to promote the City of Fredericksburg, Spotsylvania County, and Stafford County to attract visitors and tourists since 1994, and;

WHEREAS, a Tourism Marketing Agreement dated August 25, 2016 (the "Agreement") was executed to clarify and further expand a Regional Tourism Marketing Program, and;

WHEREAS, the Agreement is a three-year agreement and is set to expire as of June 30, 2019, and;

WHEREAS, Stafford County as per its own Economic Development Strategy (2015) is preparing a "coordinated tourism plan", and;

WHEREAS, the City of Fredericksburg is undertaking a study to consider its own appropriate resources (staffing, budgetary, etc.) to its tourism operations, the economic impact of tourism marketing and evaluation of City funds spent on such, its role in the regional tourism effort, and exploring other options for tourism marketing such as a convention and visitors bureau, and;

WHEREAS, Stafford County's plan and the City of Fredericksburg's study will not be completed until at least June 30 (Stafford) and likely December of 2019 (Fredericksburg), and;

WHEREAS, administrators of the Agreement recommend that the Agreement be extended through fiscal year 2020 (June 30, 2020) so that the above noted plan and study may be completed;

NOW, THEREFORE, BE IT RESOLVED that the Spotsylvania County Board of Supervisors hereby formally requests that the Agreement be extended through June 30, 2020; and

BE IT FURTHER RESOLVED that the Spotsylvania County Board of Supervisors hereby authorizes and directs the County Administrator to execute a contract on behalf of Spotsylvania County agreeing to terms substantially the same as those in the Agreement effectively extending the terms of the Agreement through June 30, 2020; and

BE IT FURTHER RESOLVED that the results of the Stafford County plan and the Fredericksburg study referenced above will be shared with the Greater Fredericksburg Tourism Partnership by December 1, 2019 in order that it may make recommendations on improved regional and local tourism marketing efforts.

<u>SUP18-0001 – Sustainable Property Holdings, LLC (sPower Solar Energy Facility Site A)</u> (Livingston Voting District) (Public Hearing Closed)

The applicant requests special use permit approval on multiple parcels to develop a 400 MW solar energy facility on Agricultural 3 (A-3) zoned properties together constituting a site of

approximately 5,200 acres. The properties consist of 11501 W. Catharpin Rd., 12910 Orange Plank Rd., 10900 Buckland Rd., 13301 W. Catharpin Rd., 13001 W. Catharpin Rd., and 22 additional unaddressed parcels. The properties are located in western Spotsylvania County, south of Orange Plank Road, north of W. Catharpin Road, east of the Spotsylvania/Orange County line and west of Catharpin Rd. The properties are located outside of the Primary Development Boundary. The properties are identified for Rural Residential or Agricultural and Forestal Land Use development on the Future Land Use Map of the Comprehensive Plan.

The Board of Supervisors held a public hearing on February 26, 2019 and closed the hearing. The Board continued consideration of the case to March 12, 2019 and requested that staff prepare a table listing concerns raised during the public hearing process with sPower's proposal to address the concerns, staff or County consultant comment, and recommended conditions. On March 12th, the Board reviewed several of the concerns but, due to the late hour, continued the item to March 19th.

After reviewing the follow-up questions from the March 12, 2018 meeting and the list of concerns raised during the public hearing process, Dr. Trampe made a motion to table consideration of SUP18-0001, SUP18-0002 and SUP18-0003 to March 19, 2019. The motion passed unanimously.
