

MODIFICATION #4
TO
SPOTSYLVANIA COUNTY CONTRACT AGREEMENT
FOR GOODS AND SERVICES
Contract #16-08-TV-01

THIS MODIFICATION #4 TO SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR GOODS AND SERVICES is made as of _____, 2019 by and between BOARD OF SUPERVISORS OF SPOTSYLVANIA COUNTY, a political subdivision of the Commonwealth of Virginia, ("COUNTY"); and INTERSTATE RESCUE, LLC, a Virginia Limited Liability Company, ("CONTRACTOR").

WITNESSETH:

WHEREAS, the COUNTY and the CONTRACTOR entered into an Agreement titled "SPOTSYLVANIA COUNTY CONTRACT AGREEMENT FOR GOODS AND SERVICES Contract #16-08-TV-01", ("AGREEMENT") dated May 11, 2016, to obtain protective ensemble for structural firefighting (turnout gear) for Spotsylvania County; and

WHEREAS, the AGREEMENT was subsequently modified and/or renewed by "Modification #1 to Spotsylvania County Contract Agreement for Goods and Services Contract #16-08-TV-01", dated and executed on May 10, 2017, "Modification #2 to Spotsylvania County Contract Agreement for Goods and Services Contract #16-08-TV-01", dated and executed on November 14, 2017, and "Modification #3 to Spotsylvania County Contract Agreement for Goods and Services Contract #16-08-TV-01", dated and executed on May 10, 2018 ("MODIFIED AGREEMENTS"); and

WHEREAS, the COUNTY requires a continuation of these services for an additional one (1) year contract term, as is permitted under Article 2, subdivision 2.3., of the AGREEMENT; and

WHEREAS, the COUNTY and the CONTRACTOR have determined that it is to their mutual benefit to modify the AGREEMENT further by entering into this "Modification #4 to Spotsylvania County Contract Agreement for Goods and Services Contract #16-08-TV-01".

NOW, THEREFORE, the COUNTY and the CONTRACTOR in consideration of the mutual promises herein contained, and intending to be legally bound, do hereby modify terms and conditions of the AGREEMENT and MODIFIED AGREEMENTS as follows:

A. ARTICLE 2, THE WORK AND AGREEMENT TERM LIMITS, subdivision 2.3., is hereby deleted in its entirety and replaced as follows:

2.3. This Agreement shall have a term limit of one (1) year effective from May 11, 2019 through May 10, 2020 and may be renewable for one (1) additional one (1) year term at the option of Spotsylvania County. Any adjustment to pricing for future years will be equal to or less than the unadjusted percent change of the previous twelve (12) months from December of the prior year to December of the current year as indicated in Table 1 of the Consumer Price Index for all Urban Consumers (CPI-U): U.S. city average, other goods and services category, as published by the Bureau of Labor Statistics, U.S. Department of Labor. Should this index be superseded, the County reserves the right to select another appropriate index.

C. ARTICLE 4, CONTRACT PRICE AND TERMS OF PAYMENT, subdivision 4.2., is hereby deleted in its entirety and replaced as follows:

4.2. The COUNTY agrees to pay for Protective Ensemble for Structural Firefighting as follows:
