County Health Insurance Presentation

At the Board of Supervisors Budget Meeting April 11, several options for employee health insurance coverage were presented. Option plan 1 was voted on and adopted for FY20. Also presented was information on the Qualified High Deductible Health Plan (QHDHP) that had been added to the KC20 and KC30 FY20 plan offerings.

Approval to Extend Economic Development Agreement for Knife Center

The Knife Center Performance Agreement ("Agreement"), approved in 2013, was based on inducing an online retail business specializing in cutlery-related products to relocate its operations from Maryland to Spotsylvania County. The Agreement was based on the reimbursement of BPOL taxes with an option to renew for an additional five years. On June 26, 2018, the Economic Development Authority approved a first amendment to the performance agreement that renewed the agreement for an additional five-year term or until the time when the total amount of the Grant payments reached \$50,000, whichever occurred first, provided that the Knife Center maintained 20 employees per year during the renewal period. The EDA's approval was based on the company's adherence to the Agreement, the number of additional full-time jobs, average annual salary and growth in sales year-over-year.

On a motion by Mr. Skinner and passed unanimously, the Board approved the incentives cited in the first amendment to the Knife Center Performance Agreement between the EDA and the Knife Center that renewed the Agreement for an additional five-year term or until the time when the total amount of the grant payments reached \$50,000, whichever occurred first, provided that the Knife Center maintained 20 employees per year during the renewal period.

PUBLIC HEARING: May 14, 2019

WHEREAS, Thornburg Towne Centre, L.L.C. and Thornburg Enterprises L.L.C., requests a rezoning of approximately 10.27 acres from Agricultural 2 (A-2) to Commercial 3 (C-3). Parcel 63-A-42 (part) is approximately 48.72 acres with approximately 8.65 acres to be rezoned. Parcel 63-A-43C (part) is approximately 10.56 acres with .83 acres to be rezoned.  - § 3. This ordinance shall be in force and effect upon adoption.
