Employee FY 2020 Health Savings Account Funding

As presented during the May 14, 2019 Board of Supervisor meeting, the employee FY 2020 health plan year includes offering a Qualified High Deductible Health Plan (QHDHP) option.

Staff sought the Board's consideration as to what level the county may assist in contributing to the Health Savings Account (HSA) as part of the QHDHP option.

Spotsylvania County's proposed rates include the following staff recommended contributions into the Employee's HSA:

- HD EE Only \$100/Month (\$1,200/YR)
 - HD EE Child \$125/Month (\$1,500/YR)
 - HD EE Spouse \$175/Month (\$2,100/YR)
 - HD EE Family \$200/Month (\$2,400/YR)
