NOTICE OF REZONING APPLICATION

Tax Map Parcel 48-A-90

As the owner/s of real property located within 3,000 feet of the identified property where a Rezoning is being applied for, you are being provided with this Notice of such Rezoning request.

PURPOSE: Rezoning of a 3.952 acre parcel in the Courtland Magisterial District (Spotsylvania Tax Map Parcel 48-A-90) from Agricultural 2 (A-2) to Residential Mixed Use (MU-3) to conform with the zoning designation of the surrounding property.

The property is located off of Courthouse Commons Boulevard. The 3.952 acre parcel is currently vacant and without access. The property is surrounded on 3 sides by land already zoned for and being developed as a mixed-use residential community. The fourth side backs up to land owned by the developers of Plantation Forest Subdivision.

As an addition to "The Village at Courthouse Commons" subdivision, the requested change in zoning will permit the property to be used as an assemblage parcel for the construction of two (2) or more of the allowed residential uses identified in the MU-3 zoning. No specific plan of development has been made at this time, but the future use will comply with the County's comprehensive plan. See dark shaded area on the attached map for the location of the land being requested for rezoning.

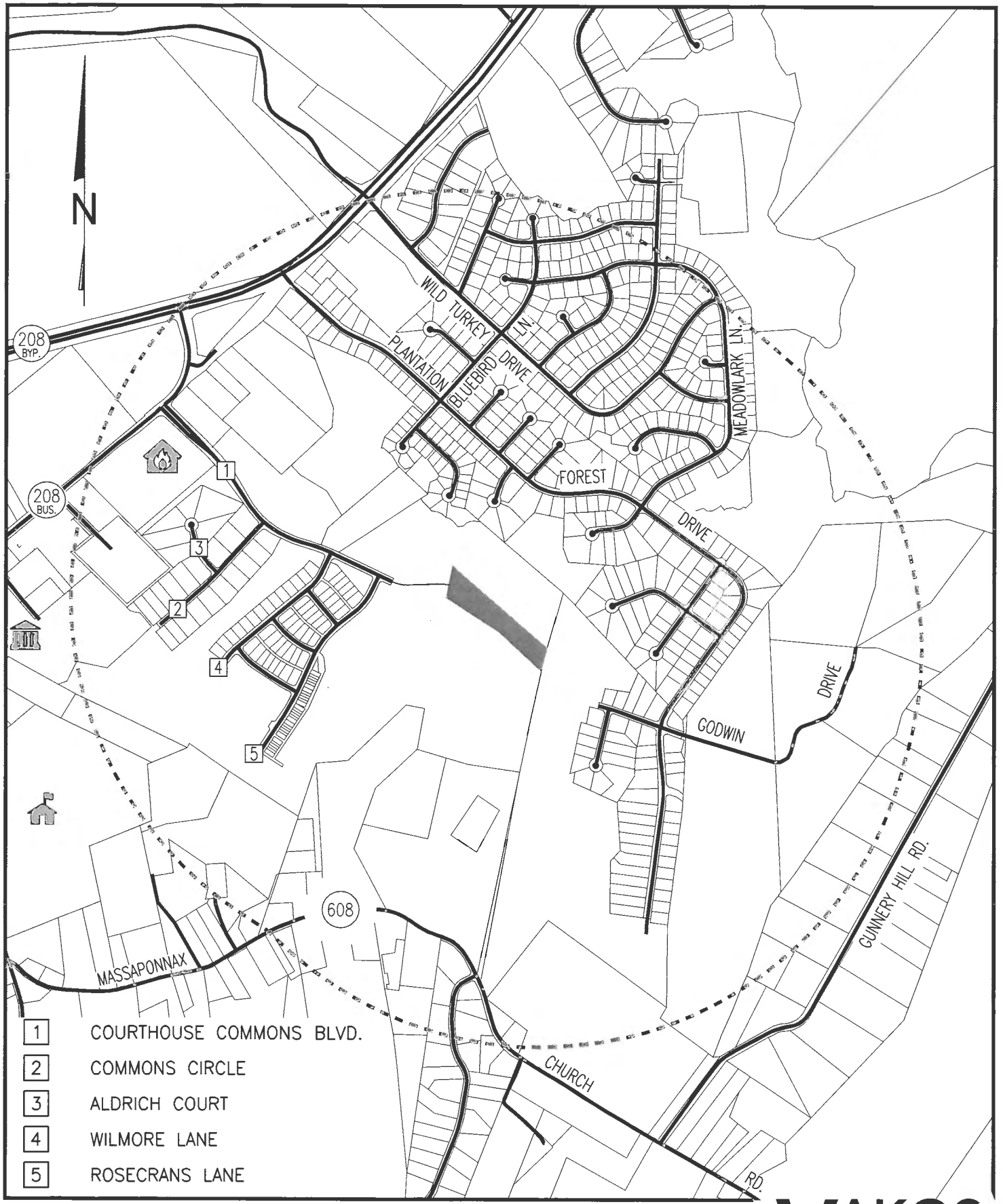
