A proposed cell tower of 105-foot monopole communication tower with a 4-foot lightning rod, for a total of 109 feet, on two parcels together constituting 8.829 acres zoned Residential (R-1).

A proposed cell tower of 109-feet is in very close proximity to daycare, physician offices and neighborhood homes.

Concerns:

1. Decreased property values.
2. Number of existing cell towers and antennas.
3. Possible health risks of radiation emitted.
4. Visibility of a 109' tower in the neighborhood.

We, the residents of Spotsylvania County, demand the Board of Supervisors deny the permit allowing the erection of the AT&T tower.
