Budget Adjustment & Appropriation for Bonuses Stemming from State Requirement for Bonuses for Certain Sheriff's Office Positions

Actions taken by the Governor and General Assembly during the 2020 Special Session required that a one-time, \$500 bonus be paid in December 2020 to Compensation Board-funded sworn positions in the Sheriff's Office, all of which were full-time positions. Out of all 255 budgeted full-time Public Safety Pay Scale positions in the Sheriff's Office, only 87 of those were sworn positions funded through the Comp Board. As such, the county expected to receive a total of \$46,828 from the State to fund the required \$500 bonus (and related FICA benefits) for 87 full-

time, sworn Sheriff's Office employees. It is only these 87 employees to whom the county was required to pay the bonus in December 2020, and the Board voted on December 8 to move ahead first only with the 87 required bonuses and for staff to return with additional information at the first Board meeting in January 2021.

Though not required by State actions and now law, County Administration recommended that this bonus be extended to <u>all</u> position titles on the Public Safety Pay Scale approved by the Board last year. This would allow for all sworn positions – not just those funded by the Comp Board – as well as Communications Operators and Communications Officers to be included in the bonus payment. Further, staff recommend that regular part-time employees in positions with titles on the Public Safety Pay Scale receive a pro-rated bonus commensurate with their FTE.

A Board member asked what it would cost to extend the bonus to full-time and regular part-time FTEs beyond just those on the Public Safety Pay Scale and then requested that staff bring back information regarding the cost of a bonus for full-time and regular part-time FTEs making \$80,000 or less. The costs and number of employees affected are shown in the following table. It should be noted that 25 (29%) of the 87 Sheriff's Office employees who received the Statemandated bonus in December have salaries of \$80,000 or more. The 87 employees to whom the State-mandated bonus was paid in December are excluded from the figures in the table.

The School Board requested \$2.5 million be allocated to the Schools' budget from available local funding as assistance in making individual electronic devices available to students, adding and providing hotspots, and otherwise making distance learning possible. Ultimately, the Board determined to appropriate \$100,000 of this \$2.5 million to the Schools for hotspots, and then reserved the \$2.4 million for consideration in conjunction with the Schools' carryover request.

Subsequently, the Schools received \$4.1 million in federal CARES funding through the State (this was in addition to two separate CARES allocation totaling \$2.9 million) and due to the fact that expenditures of that \$4.1 million had a very short turnaround time and had to be spent by the end of calendar year 2020, used the CARES funds for purchase of the individual electronic devices. The Schools have certain other pandemic-related needs for which they are requesting release of the \$2.4 million reserve:

FEMA completed an update to the Flood Insurance Rate Map (FIRM) for Spotsylvania County. Spotsylvania's last update occurred in 1998. The map revision process was administered by FEMA and the County is responsible for participating through the review and comment of the collected flood hazard data, preliminary maps and public outreach.

With this update, some properties currently not in the floodplain would be mapped into the floodplain; some properties were already in the floodplain and would remain there; and some properties would be mapped out of the floodplain.

Staff presented information related to FEMA's FIRM revision process to include actions taken to date, statistics related to impacted property owners, timelines going forward and the County's public outreach and participation in the process.

Overview of GeoHub Site for Review and Comment on the Draft Comprehensive Plan

The Planning Commission and Planning staff completed a draft update to the Comprehensive Plan (Plan). County Planning staff, working closely with the GIS Division, translated the Plan update into an interactive web-based format. The Plan is currently available for public for review and comment. Staff provided a brief overview of the website in order to showcase its content. The website provides comment boxes for each Chapter and the ability to provide comment in interactive maps embedded within the site. Comments will be collected through January 31, 2021, which the Planning Commission will consider in finalizing the Plan for public hearings.

Residential Refuse Decal Presentation

Larry Pritchett, Treasurer, gave a brief presentation to the Board regarding the proposed implementation of a residential refuse decal.

On a motion by Supervisor McLaughlin and passed 6 to 1 with Supervisor Yakabouski opposed, the Board authorized the committee's guidance to issue a one-time residential refuse sticker to be placed on the windshield with a maximum of 5 stickers per house, each sticker requires a signature for person use only, with the program to begin May 1, 2021.

<u>Direction Requested on \$2.0 Million Reserved for County Technology and Building Access Improvements</u>

In September 2020, the Board allocated \$1.3 million in local funding made available through the County's use of CARES funding for public safety salaries for the purpose of purchasing and installing necessary equipment, licensing, and software improvements associated with the County's response to the coronavirus emergency. This \$1.3 million was part of a total requested amount of \$3.3 million. The \$2.0 million balance was then reserved by the Board for these improvements, and was to be considered until after the County's and Schools' FY 2020 operating results were known.

Staff was requesting that \$1.6 million of the reserved \$2.0 million be allocated now for the purposes originally requested, and as identified below. Due to revisions in costs and refinement of needs, \$0.4 million is no longer necessary and could be shifted to the General Fund balance.
